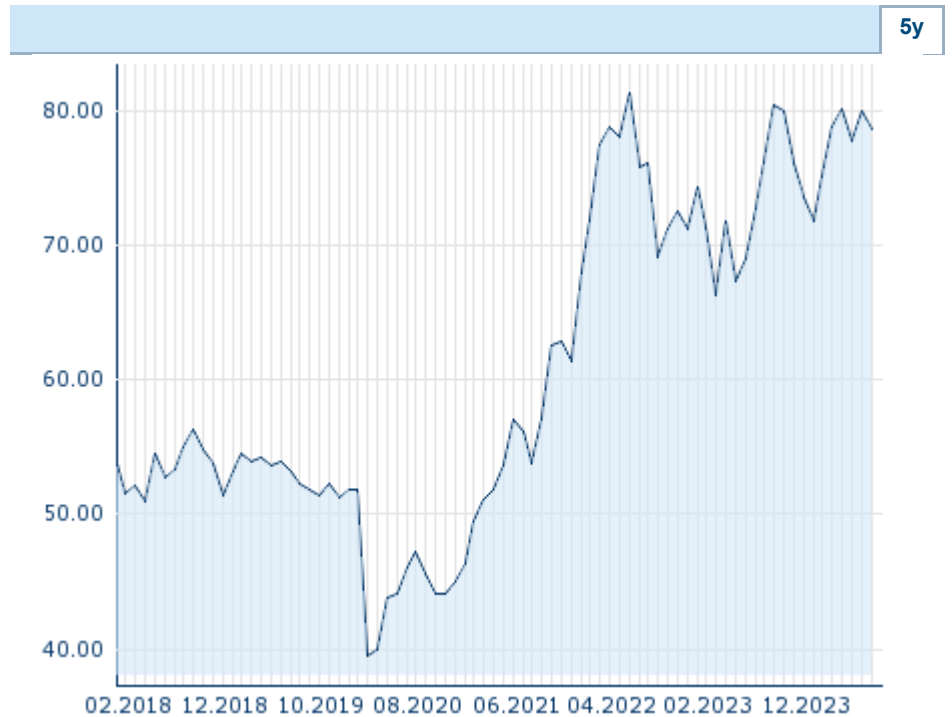
#### Secondary market
