### Description

This bond refers to the Solactive Market Leaders 25 AR Index (the underlying). It has a fixed maturity of eight years and falls due on 28/06/2025 (due date). During the life of the bond no interest accrues, and the investors do not receive any ongoing return (such as for example dividends). The redemption at the end of maturity depends on the performance of the underlying and may amount to a minimum of 100.00 % of nominal value (minimum redemption price) and to a maximum of 140.00 % of nominal value (maximum redemption price). The investor can participate in the positive performance of the underlying up to a cap

of +40.00 %. Beyond the cap investors do not participate in the positive performance of the underlying.

The redemption price is established as follows:

- (a) if the performance is at or above the cap, the bond is redeemed at 140.00 % of its nominal value (maximum redemption price);
- (b) if the performance is below the cap, the redemption price is the sum of (i) nominal value and (ii) the participation multiplied by the performance, but at least 100.00 % of nominal value (minimum redemption price).

#### Payment notes

During the life of the bond no interest accrues.

#### Settlement

This bond will be redeemed on 28/06/2025.

#### Secondary market

The bond will be issued on a continuous basis and publicly offered in Germany and Austria. From the issue date onwards the bond can basically be traded on a stock exchange or over-the-counter. Under normal trading conditions the issuer will continuously quote indicative prices. Listing at the Stuttgarter Wertpapierbörse (Baden-Württembergische Wertpapierbörse) and Frankfurter Wertpapierbörse as well as at Wiener Börse is scheduled. The decision about the admission to the respective market and the actual listing will be taken by the board of the respective stock exchanges. From admission onwards the bond can be traded on each stock exchange during trading hours.
