Description

This bond refers to the EURO STOXX Select Dividend 30 Index (the underlying). It has a fixed maturity of eight years and falls due on 29/12/2025 (due date). During the life of the bond no interest accrues, and the investors do not receive any ongoing return (such as for example dividends). The redemption at the end of maturity depends on the performance of the underlying and may amount to a minimum of 100.00 % of nominal value (minimum redemption price) and to a maximum of 160.00 % of nominal value (maximum redemption price). The investor can participate in the positive performance of the underlying up to a cap

of 60.00 %. Beyond the cap investors do not participate in the positive performance of the underlying.

The redemption price is established as follows:

- (a) if the performance is at or above the cap, the bond is redeemed at 160.00 % of its nominal value (maximum redemption price);
- (b) if the performance is below the cap, then the redemption amount equals the performance of the underlying multiplied by the nominal value, but at least 100.00 % of nominal value (minimum redemption price).

Payment notes

During the life of the bond no interest accrues.

Settlement

This bond will be redeemed on 29/12/2025.

Secondary market

The bond will be issued on a continuous basis and publicly offered in Germany, Austria and Croatia. From the issue date onwards the bond can basically be traded on a stock exchange or over-the-counter. Under normal trading conditions the issuer will continuously quote indicative prices. Listing at Stuttgarter Wertpapierbörse (Baden-Württembergische Wertpapierbörse) and Wiener Börse is scheduled. The decision about the admission to the respective market and the actual listing will be taken by the board of the respective stock exchanges. From admission onwards the bond can be traded on each stock exchange during trading hours.
