

Description

This bond refers to the EURO STOXX Select Dividend 30 Index (the underlying). It has a fixed maturity of eight years and falls due on 31/01/2026 (due date). During the life of the bond no interest accrues, and the investors do not receive any ongoing return (such as for example dividends). The redemption at the end of maturity depends on the performance of the underlying and may amount to a minimum of 100.00 % of nominal value (minimum redemption price) and to a maximum of 160.00 % of nominal value (maximum redemption price).
