

Description

This bond refers to the EURO STOXX Select Dividend 30 Index (the underlying). It has a fixed maturity of eight years and falls due on 31/05/2026 (due date). During the life of the bond no interest accrues, and the investors do not receive any ongoing return (such as for example dividends).
