

Description

This bond refers to the STOXX Global Select Dividend 100 Index (the underlying). It has a fixed maturity of seven years and falls due on 31/01/2026 (due date). During the life of the bond no interest accrues, and the investors do not receive any ongoing return (such as for example dividends). Under normal trading conditions the issuer will continuously quote indicative prices. Listing at Stuttgarter Wertpapierbörse (Baden-Württembergische Wertpapierbörse) is scheduled. The decision about the admission to the respective market and the actual listing will be taken by the board of the respective stock exchanges. From admission onwards the bond can be traded on each stock exchange during trading hours.
