

Description

This bond refers to the STOXX® Global Select Dividend 100 Index (the underlying). It has a fixed maturity of seven years and falls due on 29/04/2026 (due date). During the life of the bond no interest accrues, and the investors do not receive any ongoing return (such as for example dividends).
