

Description

This bond refers to the Solactive Megatrends RISE Index (the underlying). It has a fixed maturity of eight years and falls due on 31/05/2027 (due date). During the life of the bond no interest accrues, and the investors do not receive any ongoing return (such as for example dividends). The redemption at the end of maturity depends on the performance of the underlying and may amount to a minimum of 100.00 % of nominal value (minimum redemption price) and to a maximum of 150.00 % of nominal value (maximum redemption price). The decision about the admission to the respective market and the actual listing will be taken by the board of the respective stock exchanges. From admission onwards the bond can be traded on each stock exchange during trading hours.
