

Description

This bond is a security that pays a variable coupon and has a maturity of eleven years. At the end of maturity, the bond is redeemed at 100%. The bond comes with a quarterly coupon whose magnitude depends on the development of the 3M Euribor. The coupon is basically equivalent to the 3M Euribor p.a., but it comes with a floor (i.e. minimum coupon) of 0.85% p.a. and a cap (i.e. maximum coupon) of 1.83% p.a.

If the 3M Euribor is traded below the floor or above the cap, the investor will receive said floor or cap (in terms of face value).
