

## **Description**

This bond refers to the Solactive ERSTE Future Invest Index VC (the underlying). It has a fixed maturity of nine years and falls due on 04/10/2029 (due date). During the life of the bond no interest accrues, and the investors do not receive any ongoing return (such as for example dividends). The redemption at the end of maturity depends on the performance of the underlying and may amount to a minimum of 90.00 % of nominal value (minimum redemption price). The participation in the positive performance of the underlying is not limited by a maximum amount.
