

Description

This bond refers to the Solactive ERSTE Future Invest Index VC (the underlying). It has a fixed maturity of nine years and falls due on 04/10/2029 (due date). During the life of the bond no interest accrues, and the investors do not receive any ongoing return (such as for example dividends).
