

## Description

This bond refers to the STOXX Global Select Dividend 100 Index (the underlying). It has a fixed maturity of ten years and falls due on 28/02/2030 (due date). During the life of the bond no interest accrues, and the investors do not receive any ongoing return (such as for example dividends).
