

Description

In principe, this bond is a security with a maturity of fifteen years, that pays a fixed coupon of 0.95 % p.a. At the end of maturity, the bond is redeemed at 100 % in terms of face value.

The Issuer has the right to terminate at the interest date in 2025. If the issuer exercises this right of termination, the term of the bond will end prematurely after five years and no further interest payments will be made.
