

## **Description**

This bond refers to the Index "Solactive ERSTE Future Invest VC" (the underlying). It has a fixed maturity of ten years and falls due on 02/09/2030 (due date). During the life of the bond no interest accrues, and the investors do not receive any ongoing return (such as for example dividends). The redemption at the end of maturity depends on the performance of the underlying and may amount to a minimum of 100.00 % of nominal value (minimum redemption price).
