

## **Description**

This bond refers to the Index "Solactive ERSTE Future Invest VC" (the underlying). It has a fixed maturity of ten years and falls due on 30/09/2030 (due date). During the life of the bond no interest accrues, and the investors do not receive any ongoing return (such as for example dividends).
