

#### Index/Participation Certificates | Description

With this Erste Group index certificate investors directly participate on the performance of the underlying instrument, Solactive ERSTE Immoaktien Index. This index comprises the six largest Austrian and German real estate shares. The composition of the index is dynamic and is recalculated and adjusted quarterly.

The certificate has an unlimited term and is suitable for long-time investment. With a management fee of 1 % p.a. the cost structure is interesting. The certificate is exchange traded.

The index certificate is based on the Solactive ERSTE Immoaktien Index NTR. The index represents the six largest real estate shares of Austria and Germany. The shares must be denominated in EUR and classified as real estate shares. A market capitalization of at least EUR 500 million ("free float") applies to new index constituents. The composition of the index is checked and recalculated on a quarterly basis ("rebalancing"). The shares are then equally weighted.

#### **Secondary market**


