### **Description**

This bond refers to the Index "Solactive ERSTE Green Invest Index VC" (the underlying). It has a fixed maturity of four years and falls due on 02/08/2027 (due date). During the life of the bond no interest accrues. The redemption at the end of maturity depends on the performance of the underlying and may amount to a minimum of 104.00 % of nominal value (minimum redemption price). The participation in the positive performance of the underlying is not limited by a maximum amount.
